- a) Kitchen Update – sink added to quote bringing price to £3797 including VAT. SL has paid a 20% deposit of £760. Kitchen to be fitted on Monday 13<sup>th</sup> August. SL informed the meeting that the sponsor is willing to give a donation towards the cost of the kitchen. MS has arranged for a larger water heater with a longer arm to be fitted.
- b) MS has researched the Village Hall lighting on the internet and discovered that the ballast in each fitting can often be problematic. A new ballast costs between £15 and £20 pounds. MS inquired at Drakes and their LED tubes are £58 each. Replacing the ballasts is quite expensive so it may be more prudent to replace faulty light fittings.
